Q CHRISTIAN FELLOWSHIP HELD ITS ANNUAL CONFERENCE VIRTUALLY IN JANUARY 2022. OVER 1,000 ATTENDEES EXPERIENCED A WEEKEND OF WORSHIP, PRAYER, TEACHING, AND FELLOWSHIP.
